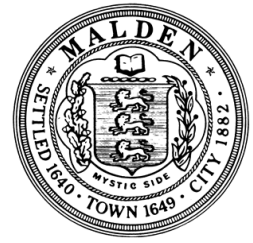

MALDEN CITY COUNCIL NOTICE OF PUBLIC HEARING

In accordance with the requirements of Chapter 166 of the General Laws, you are hereby notified that the Malden City Council will hold a virtual public hearing at 7:00 P.M. on Tuesday, March 30, 2021 on petition from Massachusetts Electric d/b/a National Grid of North Andover, Massachusetts:

Petition: National Grid, 1101 Turnpike Street, North Andover, MA

- Eastern Avenue – Plan # 29821242 – to install beginning at point approximately 90 feet northeast of the centerline of the intersection of Eastern Ave. and Maplewood St. and continuing approximately 8 feet in a northwest direction. Install 2-4 Primary Duct approximately 8 ft. northeast from existing pole (P#1952) towards 888 Eastern Ave., for the purpose of serving the customers with electric service.

Petitions and plans are available for public review in the City Clerk's Office, 2nd Floor, 215 Pleasant Street, Malden, MA **(BY APPOINTMENT ONLY)**.

In accordance with Governor Baker's March 12, 2020 Order Suspending Certain Provisions of the Open Meeting Law, G.L. c. 30A, §18, and Governor' Baker's March 23, 2020 Revised Guidance on Order by the Governor Prohibiting Assemblage of More than Ten People, this hearing will be virtual and conducted via remote participation to the greatest extent possible. No in- person attendance by members of the public will be permitted, and all effort will be made to permit remote public attendance and participation in this virtual hearing via technological means, in the manner specified below, and if available, via public broadcast of the meeting by Malden Access Cable Television on public access television channels.

If you wish to remotely participate in the public comment portion of the hearing:

Using Zoom:
