Enclosed is a Campaign Finance Report (Form CPF M 102) for use in reporting pre-election receipts and expenditures. This report must be filed in the City Clerk's Office by 5:00 pm Monday, October 25, 2021.

- If your committee was organized THIS year, the reporting period for this statement is from the date of organization through October 15, 2021.
- If your committee was organized PRIOR to this year, the reporting period for this statement is from January 1, 2021 through October 15, 2021.
- If you had a Preliminary in September, the reporting period for this statement is from August 31 through October 15.

Your report must disclose all campaign finance activity (all money and in-kind contributions received, expenses paid and liabilities incurred) for the period in question. All receipts and expenditures in excess of \$50.00 must be itemized. In addition, you must solicit the occupation and employer of anyone who contributes \$200 or more and report such information, if it is provided.

The State Office of Campaign and Political Finance provides a free web-based program to assist you in preparing your report. You are strongly encouraged to make use of this resource. To obtain an identification number and password for Reporter 7, you must contact OCPF at 617-727-8352. All of you should have received notice from OCPF that beginning in 2022 all candidates with active campaign accounts will begin reporting directly to them. **You still must submit your pre-election and year end reports with this office despite this change.**

Dear Ms. Philippe:

As a candidate for municipal office you were required to file a campaign finance report (Form CPF M102) on or before October 25, 2021. As of the date of this letter, our records indicate that this report has not yet been filed.

The campaign finance law, M.G.L. c. 55, requires me to notify the director of OCPF if your campaign finance report is not filed within 10 days of receipt of this letter. In addition, in accordance with section 3 of chapter 55, if the director of OCPF determines that a campaign finance report is late the law requires the director to assess a penalty of twenty-five dollars per day up to a maximum penalty of \$5,000 for each late report.

The penalty is assessed personally against the candidate or a candidate's committee or the treasurer of any other political committee such as a ballot question committee. The penalty may not be paid by the political committee.

If you do not file, the above referenced report within 10 days of receipt of the letter this office will notify the director of OCPF as required by law.


