Dear Ms. Philippe:

I am writing today to confirm receipt of your CPF M 102 Campaign Finance Report as submitted to this office on January 19, 2022. Unfortunately, I am rejecting this report for reasons as listed below. Since there currently is an open violation on file with the Office of Campaign and Political Finance in your name, please be advised that a copy of this packet is being cc'd to their office as well with supporting documentation enclosed.

- The reporting period of this report is insufficient. It begins on October 26, 2021 but you began your candidate committee in May 2021 and have not submitted any financials from May through October 25.
- Committee information block with Treasurer contact information is crossed out.
- Affidavit of Committee Treasurer is not signed.
- Total receipts only account for one deposit, made by you on October 28, 2021 but do not reflect any of the money that came in from your online GoFundMe page, which began in July 2021 and is still active for donations as of the writing of this letter.
- Total expenditures only account for one payment, made to Connolly Printing on October 28, 2021, for flyers. Does this payment include the cost of lawn signs that were displayed prior to October 28? If not, that expenditure must also be recorded.

Please address the above noted concerns and resubmit your report to both this office and OCPF expeditiously.
